Resolution No. 2014-8 - "A Resolution urging Ohio voters to support State Issue 1, renewal of the State Capital Improvements Program, on the May 6, 2014 ballot" was read. After discussion, Mr. Gale moved that said Resolution be adopted as read, which motion was seconded by Mr. Taplin.

On behalf of the Communication and Community Outreach Committee, Ms. Merritt reported that the Village Voice will be published soon, and the Mayor indicated that he would have content for it ASAP. The Village will be holding its Memorial Day Ceremony in the cemetery this year on May 26 at 9 a.m., and there was discussion regarding the veterans that are buried in the cemetery. Mr. Scheucher reported that unique visitors to the Village's website continue to increase and we are not certain why.

Mr. Scheucher stated that the Finance Committee had met and discussed the fact that property taxes had been received late. There was also a bond purchased ratified which had a dismal rate of return. The Finance Committee is also thankful to the Clerk-Treasurer for her restated accounting reports.

Mr. Taplin, on behalf of the Safety Committee deferred to Chief DeWitt for a report. The Chief reported on a St. Patrick's Day OVI car crash on Eagle Road which had crashed in Willoughby Hills and left the scene. There was also a one-car vehicle crash, not OVI related, that had damaged the serpentine wall on Waite Hill Road. There was also discussion regarding a mutual aid response to Eisenhower Drive in Kirtland, heroin use in Lake County and alarm drops. The Chief had the alarm drop issue under review; some expected moves into and out of the Village are expected to resolve the issue.

Mr. Gale, on behalf of the Service Committee, along with the Mayor and all of Council thanked the Service Department for their good service this past winter. Seven hundred tons of salt were used this winter. There was discussion of the transfer of the Waite Hill Land Conservancy to the Western Reserve Land Conservancy and its impact on the Village's lease obligations, including whether the Village needs to continue to maintain the property. The grass in front of the Village Hall was also discussed, along with a property that had PODS located on it. There was also discussion regarding properties that straddle the school district boundaries of the Kirtland School District and the Willoughby Eastlake School District. Mr. McClain reported that the Village will be taking possession of its new truck in July.

There being no further business to come before the Council, Mr. Taplin moved to adjourn the meeting, which motion was seconded by Mr. Cox.
