MINUTES OF A REGULAR MEETING OF THE COUNCIL OF WAITE HILL, OHIO

January 12, 2015

Pursuant to notice given, the Council of the Village of Waite Hill, Ohio, met at the Waite Hill Village Hall at 8:02 a.m. on Monday, January 12, 2015, with Acting Mayor Ryan Cox presiding. The following members of Council were present:

Ordinance No. 2015-4 – "An Ordinance amending subsection 1141.15(b) of the Codified Ordinances of the Village of Waite Hill, Ohio, to modify the permitted side yard setback for detached accessory buildings in the R-3 Single Family Residence District." was read for the first time. Mr. Dery explained the genesis of the Ordinance and the Ordinance was referred to the Planning and Zoning Commission for a report and recommendation.

In the absence of Mrs. Merritt, there was no formal report from the Communication and Community Outreach Committee. Mr. Scheucher reported that the traffic accessing the Village's website continues to increase.

On behalf of the Finance Committee, Mr. Scheucher reported that the Committee had met and reviewed the revenue and expense projections and performed other routine business. It was noted that Jim Raimondo would be attending the next council meeting to discuss the Village's investments. The proposed cell tower lease was discussed and it appears the revenue to the Village from a single user would be about \$1,500/month, with some revenue from other tenants (co-locators) also possible.

Mr. Dery reported that the Planning and Zoning Commission had met and discussed the "No Trespassing" signs that a Metcalf Road resident wanted to post, along with surveillance cameras located on the property. It is believed that these items will not be clearly visible from neighbors' residences.

On behalf of the Safety Committee, Mr. Taplin inquired about an incident on I-90. The Chief reported that while it is not a significant portion of the patrol, officers do go to the highway and, in this instance, it was a part of the training program for new officers. There was also extensive discussion regarding the Metcalf Road power outage issue.

At Mr. Gale's direction, and as a report from the Service Committee, Mr. McClain said the new compactor would be delivered within the next few weeks and placed on the newly poured footer. The Service Department fixed a tie-rod in house, making what would have been about a \$3,000 repair bill into the \$100 part, plus the labor cost of the Service Department members who did the work.

Council agreed that the recent snow storms confirmed the need that four full-time members of the Service Department are needed.

There being no further business to come before the Council, Mr. Dery moved to adjourn the meeting, which motion was seconded by Mr. Gale.
