MINUTES OF A REGULAR MEETING OF THE COUNCIL OF WAITE HILL, OHIO

June 9, 2014

Pursuant to notice given, the Council of the Village of Waite Hill, Ohio, met at the Waite Hill Village Hall at 8:11 a.m. on Monday, June 9, 2014, with Mayor Robert A. Ranallo presiding. The following members of Council were present:

The minutes of a Regular Meeting of Council held May 12, 2014, had previously been distributed to Council. Mr. Dery moved to approve the minutes as presented, which motion was seconded by Ms. Merritt.

Resolution No. 2014-10 - "A Resolution authorizing and directing the payment of certain sums" was read. After discussion, Mr. Scheucher moved that said Resolution be adopted as read, which motion was seconded by Mr. Steudel.

Ms. Merritt, on behalf of the Communications and Community Outreach Committee, reported that a one-page Village Voice may be sent out with a calendar. The Mayor and Council briefly discussed Village residents who had recently passed away. Mr. Steudel thanked the Village employees for a fine Memorial Day ceremony, and the Mayor and Council joined in the praise and thanks. It was noted that photographs of the Memorial Day ceremony will be put on the Village's website and into the Village Voice. The Village's monthly statement of investments from Ancora and the trade confirmations will also be put on the website.

The Finance Committee had met and continued to address the method by which the Village's financial information is reported, as reported by Mr. Scheucher. There were also discussions

regarding the Local Government Fund and the paving of the Village's roads. The Committee also ratified trades that had been made.

Mr. Dery reported that the Planning and Zoning Commission had met and that neither he nor the Mayor were able to attend. The agenda was short and the meeting was, reportedly, uneventful.

On behalf of the Safety Committee, Mr. Taplin and Chief DeWitt briefly discussed the circumstances behind a recent death in the Village. A conclusion had been reached regarding the false alarms in the Village and special legislation is not going to be enacted. It is expected that the problem (which is really just two residences) will be resolved as possession of the residences is changed, and there's no need to enact legislation for such a localized problem. It was also reported that the next vehicle that the Police Department will be obtaining is an SUV.

Mr. Gale, for the Service Committee, and Mr. McClain reported that the new truck has been delivered to the Village and will be placed in service. There was a brief discussion about the timing of the disposition of the old truck, and Mr. Steudel moved to declare the 2001 International 6500 surplus property and authorize the administration to sell the truck for not less than Fifteen Thousand Dollars (\$15,0000) in such manner as the administration deems most efficacious. Ms. Merritt seconded the motion.

It was reported that salt bids had been received by ODOT and the summer-fill price will be Thirty-Six Dollars and Thirty-Seven Cents (\$36.37) per ton. There was also a discussion of the fees for cemetery plots, and Mr. Byron was authorized and directed to draft legislation to establish the new fees. A new recycling driver is now providing service to the Village, and the stability of the hillside on the Brown property, above Otis Hill, was discussed and will be evaluated by the Engineer.

Mr. Gale moved to adjourn to executive session to discuss the compensation of employees, which motion was seconded by Mr. Cox.
