## MINUTES OF A REGULAR MEETING OF THE COUNCIL OF WAITE HILL, OHIO

May 13, 2013

Pursuant to notice given, a public hearing of the Council of the Village of Waite Hill was called to order by Mayor Robert A. Ranallo at the Waite Hill Village Hall on Monday, May 13, 2013, at 8:21 a.m. The purpose of the public hearing was to take the public's input regarding Ordinance No. 2012-16 (As Amended), "An Ordinance amending certain sections of the Zoning Code of the Codified Ordinances of the Village of Waite Hill, Ohio, to amend the procedures for amending the Zoning Code, and repealing certain ordinances." Mayor Ranallo opened the public hearing. No member of the public spoke for or against the ordinance. Mayor Ranallo closed the public hearing at 8:21 a.m.

Pursuant to notice given, the Council of the Village of Waite Hill, Ohio, met at the Waite Hill Village Hall at 8:21 a.m. on Monday, May 13, 2013, with Mayor Robert A. Ranallo presiding. The following members of Council were present:

Also in attendance were Clerk-Treasurer Janet Mulh, Law Director Stephen Byron, Police Chief Keith DeWitt, Service Department Foreman Paul deWit, and Officer Tom Swaidner from the Waite Hill Police Department and his family.

requires that ordinances be read on three different days, which motion was seconded by Mr. Taplin.

Mr. Steudel reported on the activities of the Charter Review Commission, which has met twice and will be meeting again on Friday, May 17, 2013. The Commission is looking at the organization of the Village's employees and discussing possible changes to make the employer-employee relationships more flexible, to be managed by the Village administration and Council, via ordinance, rather than required by the charter (e.g. eliminating the charter status of the Director of Public Service and eliminating the term of the Clerk-Treasurer).

Ms. Merritt, on behalf of the Communication and Community Outreach Committee, advised Council that there may not be a band for the summer picnic, but that is still being determined. It was decided that Saturday, July 21, 2013, would be the day of the Summer Picnic. On June 28, 2013, at 7 p.m., there will be a Wine Tasting at a resident's home on Hobart. A shredding day, with the Shredding Network, has also been planned.

Mr. Scheucher reported that the Finance Committee had met immediately prior to the Council meeting and had reviewed the prior meeting minutes and the Treasurer's Report. The Committee had also ratified the purchase of two new investments for the Village and discussed the various differences between the types of levies that are available under law.

Mr. Dery noted that the Planning and Zoning Commission had met, and the minutes of the meeting had been distributed. There was discussion regarding a possible lot consolidation.

Mr. Taplin, on behalf of the Safety Committee, deferred to Chief DeWitt to report on various Police Department issues. Chief DeWitt reported that the Lake Health race route, that had been going to go through the Village on Hobart (north from Kirtland) and east on Eagle Road (to the Kirtland line), was now going to be going through Chapin Forest instead.

Further, after conversations with certain Village residents, there will be project completion by July 1, 2013, for one Eagle Road resident (to the west of Gardenside) and the removal of the "SOS" storage container from the residence at the intersection of Hobart and Eagle.

Mr. Gale reported that the Service Committee had been interviewing for a full-time service department position and had interviewed two applicants (and would be interviewing at least three more). There was also discussion regarding the repair of the Waite Hill Road (Otis Hill) guardrail, by the intersection with Drury Lane. The hope is to make the repairs inhouse. The Service Department is also developing short term and long term projects to accomplish, within the limits of the Department's budget.

The Mayor reported that he will be meeting with the Western Reserve Land Conservancy and that they will be discussing land maintenance issues.

There being no further business to come before the Council, Mr. Taplin moved to adjourn the meeting, which motion was seconded by Ms. Merritt.
