Mr. Steudel reported, on behalf of the Beautification Committee, that the Service Department had nicely decorated the intersections for the holidays.

On behalf of the Cemetery Committee, Mr. Steudel reported that there had been one burial in the last month - Mr. Richard Steudel, Sr.

Mr. Ranallo had no report from the Compensation Committee.

Mr. Cox stated that the Finance Committee had met and discussed the 2011 budget and will be further reviewing the salary and debt schedules.

Mr. Dery noted that the draft of the minutes of the Planning and Zoning Commission had been distributed. He commented that the Perrino project, located in the Waite Hill portion of the Chapin Ledges development, was being reviewed for a proposed lake. They are also seeking a kitchen in their walk-out basement, and there may be a future bedroom on that level that raises concerns that the home could be converted into a multi-family residence. The property owner has offered to place deed restrictions on the property to preclude such a use of the home.

Mr. Gale reported that the purchase of the police vehicle was the only business to come out of the Safety Committee.

Mr. Cox had no report from the Service Committee.

Mayor Baldwin noted that he had received Matt Crawford's resignation, effective at the end of this Council meeting, and that he will be circulating some names of people that may be appropriate replacements for Matt on Council. Separately, there may be a citizens' commission appointed to study the Village's financial condition and to make recommendations to Council regarding various issues.

Matt Crawford thanked everybody for his time on Council, and everybody thanked Matt for his service to the Village.

There being no further business to come before the Council, Mr. Gale moved to adjourn the meeting, which motion was seconded by Mr. Cox.
