January 14, 2013

Pursuant to notice given, the Council of the Village of Waite Hill, Ohio, met at the Waite Hill Village Hall at 8:04 a.m. on Monday, January 14, 2013, with Mayor Robert A. Ranallo presiding. The following members of Council were present:

The Village will be seeking quotes to correct the problem, which may include a change of the design of the building. Norm Casini had come to the Village Hall twice to consult on the matter. Blinds will be installed in the Council chamber. There was also a discussion regarding electrical surge protection and the warranty of the surge protector, and Council discussed how future
