Mr. Cox reported that the Finance Committee had met prior to the Council meeting and that Mr. Jim Raimondo presented a report on the Village's investments. The Committee will be studying contingencies regarding the various revenue streams, including the estate tax.

On behalf of the Planning and Zoning Commission, Mr. Dery noted that the Commission had met, and the minutes had been distributed to Council. There was a brief discussion regarding the new home that is going to be constructed on Hobart Road, south of its intersection with Markell and Waite Hill Roads.

Mr. Taplin had no report from the Safety Committee, but the Chief reported that there will be a Memorial Day memorial service to dedicate the new flag pole. A new plaque has also been donated.

There was no report from the Service Committee, other than noting that there had been the burial of a former resident (Dr. Bell) in the cemetery.

There was discussion, but no action taken, regarding the Village's window treatments. There was also discussion regarding the Village's dental and vision benefits, but no Council action was required.

There being no further business to come before the Council, Mr. Taplin moved to adjourn the meeting, which motion was seconded by Mr. Cox.
