

**ORDINANCE NO. 2023-4**

**AN ORDINANCE  
PROVIDING ADDITIONAL COMPENSATION FOR EMPLOYEES OF THE  
VILLAGE OF WAITE HILL FOR QUALITY SERVICES RENDERED IN THE  
YEAR 2022, AND DECLARING AN EMERGENCY.**

WHEREAS, residents of the Village of Waite Hill have generously contributed funds for the purpose of the Village providing additional compensation to employees of the Village for the quality services that were provided to the Village in 2022; and

WHEREAS, the Mayor and Council of the Village of Waite Hill concur in the evaluation of the quality services provided by Village employees in 2022; and

WHEREAS, the Mayor and Council find and determine that additional compensation should be awarded to Village employees for quality services that were rendered by the Village's employees in the year 2022.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE  
OF WAITE HILL, LAKE COUNTY, STATE OF OHIO:**

SECTION 1. That the Chief of Police shall receive additional compensation in the amount of \$7,700.

SECTION 2. That the Service Director shall receive additional compensation in the amount of \$7,700.

SECTION 3. That the Police Lieutenant shall receive additional compensation in the amount of \$5,200.

SECTION 4. That the members of the Service Department Andrew Richards, Austyn Richards and James Riddle, and full-time members of the Police Department Brett Beckwith, Marci Gedeon, Tyler Lillash and Ed Sedmak shall each receive additional compensation in the amount of \$5,200.

SECTION 5. That the Clerk-Treasurer shall receive \$5,200.

SECTION 6. That Art Lagerstedt and Chuck Cox shall each receive \$300.

SECTION 7. That Cory Eisenberg shall receive \$700.

SECTION 8. That the compensation authorized by this Ordinance shall be in addition to other compensation to the aforementioned employees provided by other legislation.

SECTION 9. That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Waite Hill and, further, provides for the usual daily operation of a municipal department; wherefore, this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
