**A RESOLUTION
THANKING ALLAN CLOUGH FOR HIS YEARS OF
SERVICE TO THE VILLAGE OF WAITE HILL**

WHEREAS, Mr. Allan Clough began his service to the Village as a member of Village Council in September of 1988; and

WHEREAS, in his capacity as Architect Advisor of the Village's Architectural Board of Review, Mr. Clough has devoted countless hours (days and years) of service, gave good architectural counsel over numerous contentious meetings, and worked to resolve complex and thorny issues; and

WHEREAS, Mayor Robert A. Ranallo remembered Mr. Clough's contributions as follows:

Al always provided great perspective. He had a wealth of knowledge and experience and was not afraid to share his opinions. He consistently used his deep reservoir of talent to advance the interests of the Village.

WHEREAS, Ken Dery, Planning & Zoning Chair, honored Mr. Clough as follows:

Al Clough has been the embodiment of an expert and dedicated architectural advisor. I have worked with him on the Village's Architectural Board of Review for over 23 years and he was always smart, caring, fair and reasonable in his approach. Al helped many a village resident to a wise resolution of plans that may not have been the best that they could achieve. He was steady and experienced in balancing the goals of the resident with the quality and look of our special place. A gentleman: he will be missed.

WHEREAS, Joe Giglio, Architect Advisor, honored Mr. Clough as follows:

Al Clough has been a longtime friend and colleague for nearly 35 years. Al is one of a few remaining architects that I know who truly understands his craft. In this age of computer generated architecture, Al's knowledge of traditional architectural detailing is becoming a lost art that is no longer taught in the schools. SECTION 3.
