MINUTES OF A REGULAR MEETING OF THE COUNCIL OF WAITE HILL, OHIO

January 13, 2025

Pursuant to notice given, the Council of the Village of Waite Hill, Ohio, met at the Waite Hill Village Hall on Monday, January 13, 2025. The Council Meeting was called to order at 8:04 a.m., with Mayor Ryan W. Cox presiding.

Ms. Bowden, Chair of the Communication and Community Outreach Committee, was not in attendance, and no report was distributed.

Mr. Scheucher reported on the Finance Committee meeting and a copy of the report for the month is appended hereto and incorporated in these Minutes by reference.

Ms. Hiltsley, reporting on behalf of the Planning and Zoning Commission and Architectural Board of Review, reported that the altered plans regarding roof issues for a new home on Eagle Road have been approved. A change of windows, however, was not approved and will be further addressed at the January 2025 meeting. There was discussion regarding limiting the numbers for accessory buildings, which are currently only limited by the amount of acreage that a property has (a property may have accessory buildings up to the limit of one percent (1%) of the acreage).

Ms. Winterer deferred to Chief Dondorfer, reporting for the Safety Committee. The Chief noted that it had been a quiet month and briefly discussed the Police Department's activities denoted in the report. Continuing professional training for Officers will be 24 hours in 2025. On behalf of the employees, the Chief thanked the residents of the Village for the additional compensation. The WENS (Wireless Emergency Notification System) has generated positive feedback. New portable radios are coming in, and the evidence locker is being upgraded. The Mayor thanked the Chief for hosting the Mayor's daughter and her third grade class.

January 13, 2025 Minutes #6

Mr. Doty, as Chair of the Service Committee, deferred to Service Director Haynik for a report. Mr. Haynik stated that since it has been snowing nearly every day, there is the possibility of running out of salt. The sink-hole on Metcalf Road has been repaired at a cost of \$2,400. Tree work in the cemetery has begun. The truck bed build has not happened, there is concern that the original vendor that had agreed to do the work is going out of business.

Mayor Cox reported that the Fire/EMS contract with the City of Willoughby Hills is being renegotiated. The Village stopped paying CPI increases in 2020 and will be paying those increases in a lump sum of approximately \$27,000. There were about seventy (70) calls per year, only forty-six (46) of which involved a vehicle from Willoughby Hills actually coming to the Village. There may also be a capital contribution from the Village to the City. Council would need to approve the new agreement, once it is finalized. The Mayor also reported that negotiations with cell phone tower providers are ongoing.

There being no further matters to come before Council, Mr. Scheucher moved to adjourn the meeting, which motion was seconded by Mr. Doty.

Finance Committee Report – January 13, 2025, Meeting

The Committee executed its standard agenda approving the November meeting minutes.

The Auditor's Schedule A was received. Property tax revenue projection for 2025 is \$1,377,497 increasing approximately 28% and \$300k over 2024 revenue.

Local Government Fund revenue for 2024 finished at \$170,220, \$7,374 behind 2023.

Interest income for 2024 totaled \$198,615, \$32,066 ahead of 2023.

Total revenue for 2024 was \$1,641,051, \$96,574 more than 2023.

Total expense for 2024 was \$1,990,492, \$155,496 more than 2023, the Mack Truck balance (\$135,704) representing the predominant expense increase.


Total funds at year end 2024 were \$8,647,346 decreasing \$248,014 compared to total funds at the end of 2023. Note, the projected increase in property tax revenue in 2025 could substantially offset the typical decline experienced in prior years.

Total fund trajectory estimates December 2019 to have been \$9,912,326 vs. the December 2029 projection to be \$8,245,940, a decline of \$1,666,386 over 10 years, said decline averaging \$166,639 per year, an average decline of -2.02% per year. While the total funds trajectory is flattening from decline in decline rate, the General Fund trajectory is now predicting a decreasing balance in the years

Star Ohio annualized yield as of 12/6/2024 was $4.52\% \checkmark$ down from 4.97% with average days to maturity of 25.9 \uparrow up from 24.9 (yield decreased and longevity increased slightly since last month).

Note, for 2025, there will be an annual increase in the Willoughby Hills fire contract in the amount of \$13,176 and a nonrecurring true-up charge of \$26,420 (an overall increase in fire costs of approximately \$40k in 2025).
