On behalf of the Communication and Community Outreach Committee, Ms. Merritt reported that the newsletter went out. The only feedback the Village has received is some new residents ask that their name be removed from the Village's website, which was done. The Village's book club will be starting in-person meetings at Village Hall, with appropriate social distancing, on October 22, 2020.

Mr. Scheucher reported that the Finance Committee had executed its standard agenda. They approved the Minutes of the September Finance Committee meeting and Treasurer's report for September. They also ratified the purchase of a \$250,000 FNMA bond. The Committee also discussed the expenditures of the CARES Act money and the status of the road and bridge projects.

The Planning and Zoning Commission met on September 28, 2020, as reported by Mr. Knezevic. They held a public hearing for a zoning ordinance (which no one attended) and approved a small chicken coop. The proposed new residence on Metcalf Road was formally denied because the proposed location is about seventy-five feet (75') from the side lot line, which will require a variance. The proposed new home was greatly improved as the owner has agreed to suggestions that the architect advisors have recommended and incorporated them in the design. The ABR also approved a revised (as built) set of plans for the new accessory structure on Mountainview. A new driveway was approved for a property on Smith Road, which had previously used a portion of a neighbor's land for access.

Mr. Taplin had no report from the Safety Committee. He did inquire whether the Police Department had been called on Sunday evening regarding gunfire. There were no calls regarding the noise.

Mr. Gale deferred to Mr. Haynik regarding Service Committee issues. Mr. Haynik indicated the Waite Hill Road bridge will be completed by early November. The Service Department is preparing for the winter snow plowing season.

Mayor Ranallo then reported that the Village will be seeking grants and loans for the Hobart Road resurfacing project. He explained that the Village is seeking a higher percentage cost of the project to be paid by the Ohio Department of Public Works, which will lower the score that the

Village will get for the project. This strategy is designed to take advantage of current economic conditions.

Mr. Gale then moved to adjourn to executive session to discuss the appointment and compensation of Village employees. Ms. Merritt seconded the motion.
