### From the Office of the Mayor

Dear Residents,

Well, spring is here. Winter arrived like a lion, went dormant like a lamb, and left like a lion, leaving us with six inches of snow on March 19<sup>th</sup>. Here's to looking forward to less no snow and many more sunny days ahead.



This letter will be singular in focus. Its singularity results from the critical importance of continued funding from our Police, Fire and Emergency levy to the Village's annual operating budget.

By way of background, in 2013, our residents approved a 6.2 mill charter levy. The levy was limited to a term of five years as a measure of accountability (as opposed to asking for a permanent tax increase), with the understanding that we would vote on its renewal five years down the road. When Council and the Administration asked the voters to pass the charter levy in 2013, we did so to preserve the police and other safety services provided by the Village.

In May 2018, it came time for the Village to seek renewal of this charter levy for a new 5-year renewal as the original term was ending. Fortunately, residents turned out and approved the renewal for a new 5-year term, with almost 80% of our residents voting in favor of passage.

We are now nearing the end of our second 5-year term of the charter levy, necessitating a need for renewal for a new 5-year term. As a result, there will be an issue initiated by Waite Hill on the May 2<sup>nd</sup> ballot seeking to **RENEW** the 6.2 mill charter levy originally passed by our electors in November 2013 for a new 5-year term. It should be emphasized that 100% of the proceeds raised by this charter levy are restricted to police and other safety services. Passage of this renewal will **NOT** result in any new tax.

Law Director Stephen Byron sbyron@waitehilloh.gov A second catalyst to the timing of our charter levy request in 2013 was a then-pending change in state law that eliminated reimbursement from the State of Ohio for the 10% rollback credit and the 2.5% primary residence property tax credit on all levies enacted after 2013. After 2013, reimbursement of those monies from the State was eliminated on all **NEW** levies but was preserved for the **RENEWAL** of all existing levies. So, passage of an extension of the term of the charter levy in 2013 enables us to continue to be reimbursed for the rollback proceeds as long as the levy is renewed.

The levy has generated \$2,435,049 in the first nine years since its passage to support our police and other vital safety services:

There has been \$2,148,274 collected in taxes, and the State has funded *an additional* \$287,239 in rollback reimbursements. 100% of these proceeds have been used to fund operating expenses for police and safety services.

If we renew this levy, the State of Ohio reimbursement of rollback proceeds to the Village will continue. Unfortunately, because the State has eliminated rollback reimbursements for all new post-2013 levies, renewal of the existing levy is the only way to preserve this significant financial benefit.

On average, over the past five years, the funds from our charter levy have represented approximately 25% of the Village's operating budget. Since passage, **ALL** the proceeds from the levy have been used to fund operating expenses for police and safety services. **NONE** of the proceeds have been used for capital expenditures or other operating expenses of the Village.

We are at a place where the continued funds from our charter levy, including the rollback proceeds that would be permanently lost if the levy is not renewed, are critically important to the preservation of police and safety services at current levels.

We have consistently strived to do our best for the Village and will continue to do so at all times. We are committed to delivering the most value possible under the circumstances and within the resources available to us.

Please vote on May 2<sup>nd</sup>, 2023 or send a mail-in ballot to the board of elections before May 2<sup>nd</sup>. In order for the Village to maintain the current levels of police and safety services in the Village, the levy needs to be renewed. We thank you for your consideration and understanding regarding this issue.

# From the Office of the Chief of Police Carl H. Dondorfer

Greetings, Residents of Waite Hill!

I hope you all are doing well. The weather may be breaking as we head into spring, and warmer temperatures are right around the corner. I wanted to remind all the residents of the Village that once the warmer temperatures arrive, Service Director Bob Haynik and I will conduct the annual survey of dead or dying trees that present a hazard to persons using the roadways within the Village. If a tree is identified as a hazard, a letter will be sent out to the resident explaining their obligation to remove the tree(s). Bob Haynik and I will be available to come out to meet with any resident and identify the hazard(s) so the issue can be taken care of in a timely fashion. I want to thank all the residents who worked with the Village last year to remove several dead or dying trees that posed a hazard. We had great cooperation throughout the Village in enhancing the safety of our roadways.

Springtime is also a good time for residents to inspect their split rail fencing. The harsh winter weather and heavy snow obviously can damage and impact the condition of this fencing. Under Section 1317.08(a) of the Codified Ordinances of the Village of Waite Hill, General Conditions, "All fences shall be maintained in good condition, and shall be structurally sound and attractively finished at all times. Any grounds between the fence and property line shall be well maintained." The Village appreciates your cooperation in maintaining the standards of split rail fencing in Waite Hill.

In my portion of the newsletter, I always make Village residents aware of what is new in the profession of law enforcement or what current crime trends are occurring within the Village or adjacent communities within Lake County. Governor DeWine recently signed Senate Bill 288 earlier this year. This Bill will strengthen Distracted Driving Laws in Ohio.

So, what does this new law involve? Senate Bill 288 designates the use of cell phones and other electronic communication devices while driving as a primary traffic offense for all drivers and allows law enforcement to immediately pull over a distracted driver upon witnessing a violation. Under the previous law, distracted driving was a primary offense only for juvenile drivers, preventing officers from stopping

adult distracted drivers unless those drivers also committed a separate primary traffic violation, such as speeding or running a red light. It was considered a secondary offense.

When I reviewed the press release on this new law, I was alarmed at some of the statistical data in the State of Ohio regarding distracted driving. From 2018 to present, there were 60,263 distracted driving accidents in Ohio, which resulted in 1,774 fatal or serious injury crashes. According to other states who have implemented this new law, those states saw a 15 - 20 % reduction in car-related incidents and lives saved.

So, what will law enforcement look for which would indicate a violation of this new law? Motorists are allowed to have a cellular device mounted for navigation purposes, you are permitted to have a cellular device held to your ear or use as a mounted speakerphone, you may use the phone when parked or stopped at a red light, and you may have full use of a device in an emergency situation.

What is not permitted is texting, using a device that is not held to your ear, using a device that is not mounted, or holding or physically supporting the device, which is indicative of texting. This new law goes into effect at the beginning of April 2023 and will allow law enforcement to lawfully stop the motorist for this primary offense. For six months, a written warning will be issued to motorists stopped for distracted driving. After the six-month grace period, law enforcement will have the authority to issue citations. Penalties include a fine of up to \$150.00 for a driver's first offense and two points on their license unless a distracted driving safety course is completed. Increased penalties can occur if the driver is a repeat offender.

I encourage all of us to comply with this new law to do our part as responsible motorists and practice safety to avoid tragedies resulting from distracted driving. Thank you for your cooperation.



What municipalities does the Lake County Building Inspection Dept. have jurisdiction over?

What exactly requires a permit?

We always recommend calling to speak with an inspector first to get clarification on what is required. Most construction requires some form of permit/approval. Some permits include but are not limited to: Structural, Electrical, Plumbing, HVAC, Gas Piping, Hydronics, Fire Alarm, Fire Sprinkler, Kitchen Hood, Hood Suppression, Room Suppression, Refrigeration, and equipment installations that are essential features in the construction or use of a structure.

How do I obtain a permit?

Our permit applications are available online at lakecountyohio.gov. Click on "Departments". Under "Building & Development", click on "Building Inspection". Applications are listed on the left side of the page. You can also bring your applications to our counter in person or submit them through the mail.

Q Can I submit permit applications and plans digitally?

Permit applications are accepted online. They can be submitted through our website at lakecountyohio.gov. Click on "Departments". Under "Building and Development", click on "Building Inspection". On the left side of the page, you will see "Document Submittal". You can also submit your applications via email at lcbd@lakecountyohio.gov.

Q How much does a permit cost?

Our 2022 Fee Schedule is available at lakecountyohio.gov. Click on "Departments". Under "Building and Development", choose "Building Inspection". The Fee Schedule is listed on the left side; however, we always welcome your calls with any questions you might have.
