Greetings to all. After a cold, gray and prolonged winter, it appears that at long last, spring and some sun are finally here to stay. Along with that comes an opportunity to bring all residents up do date on Village happenings, and a summary of some of the more significant activities follows.

Charter Levy - May Ballot

As Council, the Administration and I communicated in April, the May 8 election will include a ballot issue seeking the renewal for a term of five years the 6.2 mill charter levy originally passed by our electors in 2013. ALL of the proceeds from this levy are used to fund police, fire, EMS and public services, and renewal of the levy will not result in ANY increased taxes.

The charter levy is critical to the funding of our daily operations and enables us to continue to maintain safety and service department services at current levels. As mentioned in our April correspondence, proceeds from the levy in the four years following passage have funded approximately 21% of the Village's annual operating expenses.

Passage of the charter levy is also necessary to preserve a since-eliminated state subsidy. Over the four-year period following the levy's passage, the State of Ohio has remitted to the Village approximately \$32,000 per year (\$128,000 total) in the form of rebated rollback and primary residence property tax credits. Property tax rebates to municipalities were eliminated by the State legislature for all levies enacted after 2013. In contrast, the preservation of those rebates was grandfathered in and remains fully in place for all levies (including Waite Hill's) passed before the end of 2013. We all benefit immensely from this grandfather provision that ensures the foregoing State subsidy will continue if the 2013 levy is renewed.

Reopening of Waite Hill Road Hill

We are pleased to report that paving should be completed on Waite Hill Road by the middle of May. We recognize that this has inconvenienced residents, but work necessary to stabilize the road and the slopes on each, reinforce retaining walls and improve drainage was necessary to ensure that the road remained safe.

Other Road Projects

This summer we will undertake paving projects on sections of those roads in most need of repair. Winter's wrath has been particularly brutal this year. The Village's engineer and service department have done an extensive analysis of roads in an effort to prolong life and make repairs or replacements where and when necessary.

We anticipate that road replacements will take place in early to mid-summer on South Lane and the Markell Road hill. This will be supplemented by crack sealing. In addition, roads will undergo a striping by fall.

Increased Pedestrian Traffic

Every spring there is a perceptible increase in pedestrian traffic, runners and bicyclists throughout the Village. Please be mindful of our speed limits and exercise an extra degree of caution so that the safety of those enjoying the weather and our beautiful Village is not compromised. By the same token, if you are one of the pedestrians enjoying the beauty of the area, please dress so that you can be clearly seen by motorists.

Speaking of pedestrian traffic, there was an undercurrent of dialogue circulating through the Village earlier this year that pedestrian traffic on Village roads would be prohibited. Suffice to say, this is NOT the case. We do pay attention to safety concerns and post signage where appropriate, but there is no truth to the suggestion that pedestrian traffic in the Village would be banned.

Building Projects

Please remember that before undertaking any project that includes the building of a new structure (whether a primary residence or an accessory structure) or before starting any project that will alter the exterior physical appearance of an existing structure, prior approval from the Architectural Board of Review is required. Before starting any such projects, please call Village Hall and Robbi Laps, our Clerk-Treasurer, will outline the approval procedure for you.

WHAT CAN BE PLACED IN YOUR RECYCLE BAGS

ITEMS MUST BE CLEAN (One dirty product, or one with food waste still in it, can contaminate an entire bale containing thousands of pounds of collected plastics. This can cause thousands of recyclable items to go to a landfill instead of being recycled.):

- ✓ ALUMINUM CANS
- ✓ ALUMINUM FOIL AND BAKEWARE
- ✓ STEEL CANS AND TIN CANS (SOUP CANS, VEGGIE CANS, COFFEE CANS, ETC.)
- ✓ CORRUGATED CARDBOARD
- ✓ MAGAZINES & NEWSPAPERS
- ✓ OFFICE PAPER
- ✓ PAPERBOARD (CEREAL BOXES, TISSUE BOXES, ETC.)
- ✓ PAPER CARDBOARD DAIRY AND JUICE CARTONS
- ✓ UNSOLICTIED DIRECT MAIL
- ✓ PHONE BOOKS
- ✓ CLEAR (FLINT), BROWN (AMBER), GREEN (EMERALD) GLASS
- ✓ PLASTIC BOTTLES, JARS, AND JUGS (The code number on the bottom of your product is not a reliable indicator of whether something can get recycled. Recycle by shape!)

WHAT NOT TO RECYCLE

Not all glass and plastic should be placed into your recycling bin:

- Any glass contaminated with stones, dirt, and food waste
- Ceramics such as dishware, ovenware, and decorative items
- Heat-resistant glass such as Pyrex
- Mixed colors of broken glass
- Mirror or window glass
- Metal or plastic caps and lids
- Crystal
- Light bulbs
- Cathode-ray tubes (CRTs) found in some televisions and computer monitors
- Plastic grocery and produce sacks
